Ltda., its legal representatives, attorneys and personnel and their assets, rights, and/or properties located in Ecuador or abroad, as a result of being or having been the Company's attorneys in fact in Ecuador.

Ltda. performs any activity which has not been authorized by the Company, unless it can be considered a normal and customary activity performed in the Company's normal course of business for which Pérez Bustamante & Ponce Abogados and/or PBP Representaciones Cia. Ltda. has a general authorization; or (ii) Pérez Bustamante & Ponce Abogados and/or PBP Representaciones Cia. Ltda. acts with gross negligence or willful misconduct.

The obligation to represent the Company shall be, for all intended purposes, considered as a fiduciary duty.

SMTC-AC will pay any reasonable attorneys' fees and other costs as may be necessary to defend Pérez Bustamante & Ponce Abogados and/or PBP Representaciones Cia. Ltda., its legal representatives, attorneys and personnel, and their assets, rights, and/or properties located in Ecuador or abroad, including all necessary efforts to keep them and their assets free from any injunction or lien, including relocations of attorneys if necessary.
